## ADMISSION AGREEMENT

- 1. Only individuals with a desire to stay sober are eligible to reside at Ackorn House.
- 2. Guests must attend 3 meetings per week if working or going to school
- 3. Guests must attend 5 meetings per week when not enrolled in school or working.
- 4. House Meetings will be held and Guests are expected to attend when they are scheduled
- 5. All guests must have a sponsor or temporary sponsor and actively working a quality twelve step program.
- **6.** Meeting cards must be signed at meetings. Forged meeting cards may result in consequences.
- 7. No drinking or drug use of any kind. This includes designer drugs such as Spice & Bath Salts and prescription medication that are not conducive to 12 step recovery and that not been pre-approved by Ackorn House management.
- **8.** Anyone found to be in violation of this rule will be asked to vacate the premises immediately. The option of returning to Ackorn House after the completion of detox/program is at the discretion of the Program Manager 9. All guests agree to random drug and alcohol testing. A positive drug/alcohol screen may result in immediate discharge. 10. Anyone having knowledge of a guests drinking or using drugs, violating house rules, or engaging in unlawful activity is obligated to notify management immediately. Failure to notify management in this situation is grounds for immediate removal from the program . **11.** Guest fees are is due on the 1<sup>st</sup> of each month. 12. New Admissions are on a 30 day curfew. 11:00pm Sunday through Thursday. 12:00 am Friday and Saturday. 13. After 30 days, curfew is 11:00 pm Sunday through Thursday and weekend passed Friday and Saturday are available. 14. If relapse occurs or major rules are broken and Ackorn House decides you may continue residing here, you will abide by the signed Behavior Contract.
- 15. Guests are assigned house chores which are to be completed daily and kept up throughout the day if necessary.
- 16. Once per month, major house chores/double scrub will be done as a group under direction of House Manager.
- 17. Guests must make every effort to be compatible with all other guests and management.
- 18. Guests agree to management's checking of any personal property at any time. Nothing is to be locked without Ackorn House having access at any time.
- 19. All personal property that is brought into Ackorn House is at the resident's risk. Any personal property left at the time of the guests departure will be held until any unpaid rent or fees are brought current.
- 20. All property left beyond 15 days from the vacancy will be forfeited to Ackorn House, to be disposed of at the management's discretion
- **21.** Absolutely no borrowing of clothing, money etc. among guests is allowed.
- **22.** NO Fraternization between guests
- 23. If you plan to move, a minimum of two weeks' notice will be given to receive refund overpaid dues.
- **24.** You will be charged \$10.00 for all positive drug/alcohol tests .
